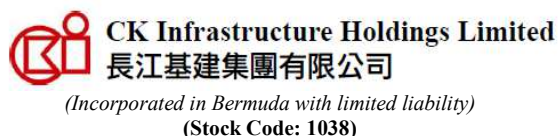

## **ANNOUNCEMENT OF INSIDE INFORMATION**

This announcement is made by CK Asset Holdings Limited (“CKA”), CK Hutchison Holdings Limited (“CKHH”), CK Infrastructure Holdings Limited (“CKI”) and Power Assets Holdings Limited (“PAH”) pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “Listing Rules”) and the Inside Information Provisions (as defined under the Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571, the Laws of Hong Kong) or as a voluntary announcement. The information contained in this announcement may not constitute “inside information” under the Inside Information Provisions for CKHH, CKI or PAH, and this announcement may therefore constitute a voluntary announcement for any of them.

CKA, CKHH, CKI and PAH (the “Companies”) have noted an announcement by APA Group on 13 June 2018 regarding a non-binding indicative proposal from a consortium comprising CKA, CKI and PAH (the “Consortium”) to acquire APA Group.

The Companies hereby confirm that the Consortium has submitted an indicative, non-binding conditional proposal for the Consortium or CKA to acquire all of the issued stapled securities in APA Group (“Non-binding Proposal”). APA Group is listed on the Australian Securities Exchange (stock code: ASX:APA) and owns and operates energy assets and investments across mainland Australia.

Under the Non-binding Proposal, the Consortium or CKA, subject to among other things, the approval of the shareholders of CKA, proposes to acquire 100% of the issued stapled securities in APA Group (comprising the ordinary units in each of APA Pipeline Trust and APA Investment Trust) from the security holders of APA Group by way of schemes of arrangement for a cash consideration of AUD11.00 per stapled security. If the Non-binding Proposal is implemented, the other members of the Consortium will seek approval from their shareholders as may be required under the Listing Rules. The Non-binding Proposal is however not conditional on such other shareholders’ approval and may therefore be undertaken by CKA alone.

There can be no certainty that any agreement will be entered into, that a formal binding proposal will be submitted, or that a transaction will be undertaken.
