Failure to complete the box will entitle your proxy to abstain or cast vote on the resolution at his/her discretion.
- (5) This form of proxy must be signed by you or your attorney duly authorised in writing or in the case of a corporation, must be either under seal or under the hand of an officer or attorney duly authorised in that behalf.
- (6) In order to be valid, this form, together with the power of attorney or other authority (if any) under which it is signed (or a notarially certified copy of such power or authority) (the "**Authority Documents**") must be lodged at the registered office of the Company, Rooms 1913-1914, 19th Floor, Hutchison House, 10 Harcourt Road, Hong Kong, not less than 48 hours before the time appointed for holding the Meeting (the "**Closing Time**").
- (7) In the case of joint holders of any ordinary share, any one of such persons may vote, either personally or by proxy in respect of such ordinary share, provided that if more than one of such joint holders be present at the Meeting (or any adjournment thereof) personally or by proxy, the person whose name stands first in the register of members shall alone be entitled to vote in respect thereof.
- (8) The proxy need not be a member of the Company but must attend the Meeting (or any adjournment thereof) in person to represent you.
- (9) If tropical cyclone warning signal no. 8 or above is hoisted or a black rainstorm warning signal is in force at 9:00 a.m. on Wednesday, 9 May 2018, the Meeting will be postponed and the Meeting will be held at 2:15 p.m. on Tuesday, 15 May 2018. You may call the Company at (852) 2122 9122 during business hours from 9:00 a.m. to 5:00 p.m. on Monday to Friday, excluding public holidays or visit the website of the Company at www.powerassets.com for details of alternative meeting arrangements. The Meeting will be held as scheduled even when tropical cyclone warning signal no. 3 or below is hoisted, or an amber or red rainstorm warning signal is in force.

You should make your own decision as to whether you would attend the Meeting under bad weather conditions bearing in mind your own situation and if you should choose to do so, you are advised to exercise care and caution.

IMPORTANT

- (a) If you wish to appoint a proxy to attend, speak and vote in your stead at the Annual General Meeting and **if you have not returned the proxy form sent together with the Notice of Annual General Meeting dated 4 April 2018 (the "Original Proxy Form") to the Company**, you must lodge this Revised Proxy Form, together with the Authority Documents (if any), at the registered office of the Company, Rooms 1913-1914, 19th Floor, Hutchison House, 10 Harcourt Road, Hong Kong, no later than the Closing Time. In this case, the Original Proxy Form should not be lodged with the Company.
- (b) If you wish to appoint a proxy to attend, speak and vote in your stead at the Annual General Meeting and **if you have already duly completed and lodged the Original Proxy Form, together with the Authority Documents (if any), with the Company by the Closing Time**, you should note that:
 - (i) **if no Revised Proxy Form is lodged with the Company**, the Original Proxy Form will be treated as a valid proxy form lodged by you but the proxy so appointed will not be entitled to vote on Resolution no. 8 to approve the Transactions;
 - (ii) **if this Revised Proxy Form is duly completed and is lodged, together with the Authority Documents (if any), with the Company by the Closing Time**, the Revised Proxy Form will revoke and supersede the Original Proxy Form lodged by you. Such Revised Proxy Form will be treated as a valid proxy form lodged by you; and
 - (iii) **if the Revised Proxy Form is lodged, together with the Authority Documents (if any), with the Company after the Closing Time**, the Revised Proxy Form will be invalid and the validity of the Original Proxy Form lodged by you will not be affected but the proxy appointed under the Original Proxy Form will not be entitled to vote on Resolution no. 8 to approve the Transactions.

PERSONAL INFORMATION COLLECTION STATEMENT

By providing your proxy's Personal Data in this form, you should have obtained the express consent (which has not been withdrawn in writing) from your proxy in using his/her Personal Data provided in this form and that you have informed your proxy of the purpose for and the manner in which his/her data may be used.

You/your proxy have/has the right to request access to and/or correction of your/your proxy's Personal Data respectively in accordance with the provisions of the PDPO.
